1. Senior Manager (HR & Admin.)

Required Educational Qualification:

The applicant must have Master's degree from a recognized Public or Private University having major in Human Resource Management either in Bachelor's or Master's degree level. 3rd Division/Class or CGPA below 3.00 out of 4.00 and below 4.00 out of 5.00 in any academic level shall be treated as disgualification.

Experience and other skills requirements:

No working experience is required for the position; however, the applicants must have the following skills and expertise:

- Strong understanding of networking and operating system fundamentals;
- Knowledge in security technologies such as firewalls, intrusion detection/prevention systems, and anti-virus software;
- Knowledge in cyber security frameworks such as NIST, ISO 27001, and CIS Controls;
- Expertise in programming languages such as Python, PowerShell, or Bash.
- Excellent report writing and verbal communication skills;
- Ability to work in a team environment.

5. Junior Officer (Shift Operation)
