



CDBL Operating Instruction – 117 - 15

October 25, 2015

To: All CDBL Participants

DPs to ensure their BO Accountholders information in the CDS is kept updated

Bangladesh Securities and Exchange Commission (BSEC) have again directed CDBL to inform all DPs that their BO Accountholders account information must be kept updated at all times. In particular, bank details must be correct with bank name, branch name, **9 digit routing number and 13 digit bank account number.**

DPs maintaining BO Accounts with incorrect or missing information are in violation of BSEC directive going back to 1st January 2014 under reference BSEC/CDS/10/2010/63 contents of which is reproduced below:-

"কমিশনের সিদ্ধান্ত মোতাবেক আগামী ৩১ শে জানুয়ারী, ২০১৪ইং তারিখের মধ্যে সকল বেনিফিশিয়ারী মালিক (বিও) হিসাবধারী তাদের স্ব স্ব ডিপির নিকট বিও হিসাবের প্রয়োজনীয় সকল তথ্য যথাযথভাবে হালনাগাদ করতে হবে। এ মর্মে সকল ডিপজিটরী পার্টিসিপেন্ট (ডিপি) - কে অবহিত করতে সেন্ট্রাল ডিপজিটরী বাংলাদেশ লিমিটেড (সিডিবিএল) - কে নির্দেশ প্রদান করা যাচ্ছে।"

Commission's deadline of 31st January 2014 for updating BO Account information passed a year & 8 months ago and yet **9 digit routing numbers and 13 digit bank account numbers** are missing or incorrect in many DP houses. All DPs must therefore take immediate action to rectify this by thorough analysis of their DP29: BO Listing Report to justify a clean report on this matter to be submitted to the Commission as soon as possible. At the same time, BO Account particulars and corresponding information to be kept updated as described below may be checked by the DPs.

10.	Other Information	 i) Nationality, Date of Birth, Resident / Non-Resident, Statement Cycle code & DP internal reference number. ii) Registration No. & Date in case of Company iii) Trading ID & Exchange ID in case of Clearing Account iv) Nominee details. v) POA on Stamp paper duly notarized
11.	Signatures	First holder, Second holder, POA & Nominees duly uploaded
