CDBL is going to launch its up-graded web based depository application soon. All DPs will be shifted gradually to the new Web VeDAS. In this regard CDBL has issued operating instruction no 125 - 18 of even date. In order to acquaint the DPs with the web VeDAS CDBL already provided training to your CDS operators. However, an overview of the new Web VeDAS is appended below for your ready reference:

1. Web enabled VeDAS will run on the following common web browsers of the mentioned versions or any of its upgraded version:

- a. Google Chrome - version 64
- b. Internet Explorer - version 11
- c. Firefox Mozilla – version 59

Supported Web Browser installers are available in CDBL's shared server at \\10.64.15.38\DP_support\CDBL Notices\Web VeDAS installers\Web browser installer. Please install the web browsers on your CDS PC;

2. Two-factor authentication has been implemented to secure login into the web VeDAS. Hence, in addition to your DPID, User Name & Password you are required to enter an One Time Password (OTP) for login. CDBL shall send a 6-digit OTP, for each and every login, through SMS and e-mail to your authorized mobile number and E-Mail ID provided to CDBL by you. **In order to prevent any unauthorized use of your web VeDAS we strongly recommend to keep your DPID, User Name, Password as well as OTP strictly secure and confidential. You are also advised to restrict unauthorized access to your registered mobile number and E-mail ID to which you will get the OTP.**

3. UPLOAD module in the new VeDAS has been enhanced by incorporating FILE upload facilities for the following:

- a. BO Setup
- b. POA/HEIR/NOMINEE/GUARDIAN Setup
- c. Link BO Setup
- d. Off-market Transaction Setup
- e. Transfer and Transmission (Transfer) Setup
- f. Transfer through Change of Ownership setup



4. New Online Report module has been introduced for Online generation of Daily BO-ISIN Balance Report (DPC3), BO Account Statement Report (DPD1) and BO Listing Report (DPC4);
5. Host Report Manager module has also been enhanced. In Web VeDAS old reports can be downloaded online at any point of time;
6. Since DPs will login directly to CDBL server through web browser they would not require to keep backup of VeDAS application as it is now done on daily basis;
7. Web VeDAS supports Network connectivity from 2 (two) Network Service Providers. Please contact Mr. Hasib Rahman (01729097086), Mr. Mashrur Sakib (01914872479) or Mr. Imam Hossain Sayem (01717915009) of CDBL Network Department to obtain multiple network connectivity and multiple Web VeDAS workstations, if you so require;
8. Web VeDAS do not require internet connection as such DO NOT connect your CDS PC to internet. However, your CDS PC must be connected to existing CDBL Network to login to Web VeDAS;
9. All pre-requisites (one time) for shifting to Web VeDAS can be installed from Web VeDAS Login page;
10. In web VeDAS all modification / enhancement / fixes in the application software shall be deployed at the CDBL end. Hence, hassle of deployment of new software releases at each and every DP installation shall be eliminated.

Training materials on Web VeDAS are available in CDBL's shared server at \\10.64.15.38\DP_support\CDBL Notices\Web VeDAS Training Materials. However, if you still require further training on Web VeDAS operation kindly feel free to contact us and we will be pleased to arrange training sessions accordingly.
