

Online Securities Balance Inquiry from CDBL - Terms & Conditions of Service

1) Online Securities Balance Inquiry Service

CDBL offers Web based BO Account Online Securities Balance Enquiry Service to the registered Beneficiary Owner (BO) Accountholders giving details of Share holdings with Portfolio Valuation of their BO Accounts who have subscribed to CDBL's Online Securities Balance Enquiry Service by filling in the prescribed Online Securities Balance Enquiry registration form through CDBL website.

2) Internet Balance Inquiry Content

Go to our website www.cdbl.com.bd and enter correct username & password to get the share balance with portfolio valuation. Example of content of Internet Balance Inquiry is given below:

3. Fees

Online Securities Balance Enquiry registration Fee of Tk. 200 must be paid through SureCash mobile banking services as per given instruction in the CDBL website

4. Account Information Requirement

The Information entered in the Online Securities Balance Enquiry registration Form must be matched with the BO account information maintained in CDS database. CDBL will verify those information before sending **Username and Password**.

5. Valid Email and Mobile number

A valid email and mobile number is mandatory to avail this service.

During registration process a confirmation email will be sent to that email address which is mentioned in the registration form and Customer must click on the confirmation link to initiate your registration. The Mobile number which was used to make payment in the mobile banking system also be matched with the mobile number mentioned in the registration form.

6. Username, Password and Security Procedures:

Upon becoming a CDBL's Balance Enquiry Service Customer, CDBL will provide the Customer with a unique Username and a temporary Password to the registered email address. Customer must change the temporary password by clicking on the "change password" option on the right hand side in the BALANCE ENQUERY box. This password will allow the Customer to access Customer's Account information. Use of the Password assigned, will indicate to CDBL Customer's acceptance of the terms and conditions governing Customer's Account(s) and this Balance Enquiry Service agreement. Each time Customer accesses his or her Account through Balance

Enquiry Service, Customer will be required to enter Customer's Password. Once logged on through valid Password the system will not request for any further transaction authorization and it stays valid until the Customer log off.

7. Customer's Responsibility:

The Customer shall be responsible for the proper and authorized use, confidentiality and security of the passwords for CDBL website access to each Account, and take every possible care to prevent unauthorized use of the Password for the Account. The Customers acknowledges that the Password are only for verification of authenticity of communications made in the name of the Customer through CDBL website access to the Account, and not for the purpose of detecting errors in communications and any such communications shall be deemed to be those of the Customer.

8. Obligations

Any discrepancies or errors in balance inquiry found must promptly be notified to the Depository Participants and CDBL (via email cdbl@bol-online.com) from the registered email.

9. Discontinuation / Termination

Online Securities Balance Inquiry Service may be discontinued by CDBL for a specific or indefinite period, with or without giving any prior notice for security reasons or system maintenance or for such other reasons as may be warranted at CDBL's sole discretion. CDBL may also discontinue the Service at any time without specifying any reason or giving any prior notice.
